Meeting Minutes

1. Call to Order and Introductions

2. Verification of Quorum

- 3 elected officers and 3 standing committee chairs
 - o Officers: Steve Brumbaugh, Jim Hobbs, Laurie Earley, Rob Titus
 - Committee chairs: Heather Benko, Lisa Thomson, Dave Lentz, Kelly Souza, Brittney Davis, Jessica, Christina Parker, Brian Mahardja, Ramona Swenson, Russ Barabe
 - Subunits: Doriane Weiler(UCSC), Arthur Barros (UCD)

3. FOCUSED DISCUSSION AND NEW BUSINESS

- Reno ExComm/Planning Committee Support
 - \$8,000 allocated for meeting attendance, plus some other pots that could apply should come to ~\$9000 total
 - o Ideas for how to allocate funds to people:
 - Priority for officers, planning committee, and active members.
 - Should consider partial funding for people who can get partially funded through work
 - Steve put out email to ExComm and planning committee to find out who needs support and how much are we ok with the amount of money we have set aside, or do we need to increase that amount?
 - Laurie quick turn-around; start by reaching out to planning committee and see how much they need before reaching out to rest of ExComm – may want to set aside funds for Rob to travel to Western Division ExComm retreat - if we solely want to support planning committee then this money is fine, if we want to support ExComm members too then we will likely need more
 - Jim if we're relying on members to work the meeting, then we should cover their expenses
 - People can go to cheaper hotels other than room blocks or Air BnB to reduce costs.
 - AFS is waiting to open up another room block in another hotel, but if it's more cost effective to get a little CalNeva room block then maybe that's the better option
 - Action Item: Steve will email the planning committee and ExComm to see what the needs are. Get itemized needs (registration, hotel, gas, etc.) and justification for attendance

- Are we ok with the amount of money we have set aside, or do we need to increase that amount? - if we solely want to support planning committee then this money is fine, if we want to support ExComm members too then we will likely need more
- We have contingency budget, can take remaining funds out of contingency
- Steve \$7,820 set aside for ExComm travel, \$1,250 for officers
- We supported ExComm members for meeting in SLO but most people did not need help
- Britt and Lisa do not need support
- Motion: Based on travel needs of our planning committee and ExComm members, we will take funding from the discretionary fund to help cover travel funds as needed (in a manner which would be decided later) - Laurie Earley
- Second: Kelly Souza
- Motion approved
- Can organize a conference call to vote on spending the money our intent is to help as many people as possible but without knowing who all needs help and how much, it's hard to know how to proceed.

Chapter Awards

- Reno Planning Highlights deciding on AFS plenaries, including Michael Mann to talk about climate change and fisheries but he costs money so looking at other climate organizations to contribute funds to have him speak.
- Wednesday night social room reserved for joint social with Sacrament/Shasta chapter of TWS, everyone will have two drink tickets and various bars set up in an open floorplan. If we want to do more than a basic gathering (i.e. appetizers) we need to put together a proposal for TWS to consider.
 - These socials are open to whoever walks in, it is not exclusive to us so others may wander in and take advantage of free food. \$5,000 for social available.
 - \$5,000 for social available but doesn't get you much if you're going through the hotel. Should plan minimum \$25/head
 - Probably won't go through hotel, better to pay corkage fee and bring in donated kegs
 - Shawn has more leverage on hotel based on societies profit. Rob will work with him to sort something out.

- Jim paid for 2020 Lake Natoma conference with IEP. Scheduling kickoff meeting at Yolo Wildlife Area on July 24th from 9-11 to talk big picture "format". Cal-Neva members are invited to participate
