Other updates:

- 1) We received sponsorship checks from Cramer, EBMUD, ESA, HDR, Metropolitan Water District, Sonoma County Water Agency and Stantec for a total of \$7250 in sponsorships. The google drive sheet is updated and accurate.
- 2) I am working on getting the chapter information put in ICF and RES's system so they can send us a check. I plan on getting that done this weekend.
- 3) 2024 proposed budget is finalized and on the google drive. 2023 actuals are updated to the best of my ability. It's difficult for me to categorize some of the charges on the account, as I was not around for much of 2023. For the 2024 proposed budget, 48k was budgeted for cost of the annual meeting and 48k was budgeted as the target income. I feel like 48k for target income may be a bit ambitious with the travel bans in effect, what do other folks think? 94k is proposed for overall chapter expenses in 2024, which is on par with what was budgeted for and actually spent in 2023.
