After returning from two weeks of working in Belize on Sunday, January 14, on Monday, 15 January, I emailed each of the field tours, field learning experience, and workshops leads about their capability to continue with the CE Events after the State's \$68B budget shortfall. All leads but one of the CDFW tours said yes as of yesterday, and as of this afternoon, I was able to regroup the tour lead (me at the moment) to move forward with more detailed planning.
